The Directors of Legal & General UCITS ETF plc (the "Company") wish to inform you of the Company's intention to amend the investment policy of the Fund as set out below.

The Fund's investment policy is to track the performance of the Foxberry Sustainability Consensus Emerging Markets Total Return Index (the "Index") by seeking to invest primarily in an optimised portfolio of equity securities that, as far as possible and practicable, consists of the component securities of the Index in similar proportions to their weightings in the Index.

In view of the current weightings of securities within the Index, it is proposed that the investment policy of the Fund be amended to reflect that the Fund will invest primarily in a portfolio of equity securities that, as far as possible and practicable, consists of the component securities of the Index in similar proportions to their weightings in the Index and may have exposure to or invest directly up to 20% of its Net Asset Value in shares issued by the same body, which limit may be raised to 35% for a single issuer in exceptional market conditions, including (but not limited to) circumstances in which such issuer occupies a dominant market position.

The prospectus supplement for the Fund (the "**Fund Supplement**") will be updated on or around 18 June 2024 to reflect this change. You are not required to do anything as a result of this notification.
